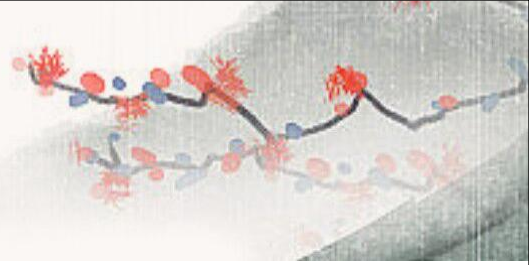

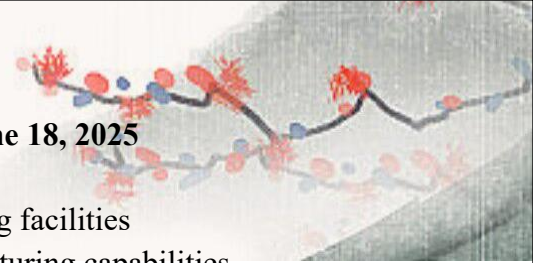

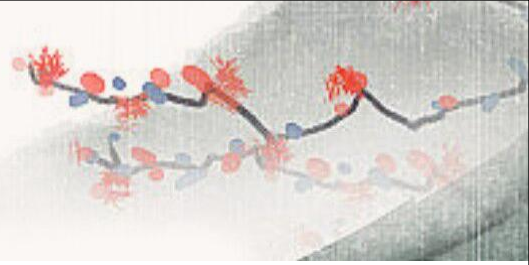

## Navigating Changing Global Trade Dynamics



- **US "Liberation Day" tariffs implemented April 2025:**
  - 20% tariff on European Union exports
  - Affecting 25% of Ireland's €72.6 billion US exports
  - Potential €6 billion reduction in Ireland-US trade over the next year
  - Irish pharmaceutical exports to US projected to decrease by half over five years
  
- **China represents a strategic alternative market:**
  - Ireland's 5th largest trading partner globally
  - €36 billion in two-way trade
  - Rare trade surplus for Ireland with China

Citizens of Ireland are eligible for a visa-free stay in China for tourism, business, or family visits for up to **30 days**.

- **United Kingdom:**

### **Visa Required**

Citizens of the United Kingdom must apply for a visa prior to traveling to China.

- **Most European Countries:**

### **Visa-Free Entry**

Citizens of 38 European countries can enter China visa-free for up to 30 days.



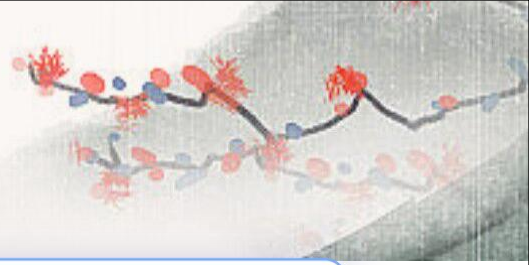
